


# Leave something in paradise

Dear hoiho supporter

The Yellow-eyed Penguin Trust wishes to ensure the long-term survival of the endangered hoiho, yellow-eyed penguin. Saving hoiho is a long-term task. Bequests will help secure its survival.

As a charitable organisation, the Trust depends entirely on grants, donations and sponsorships to raise enough funds to deliver our conservation programme. We aim to keep our capital intact, if possible, and bequests help ensure this is possible.

The Trust was formed in 1987 with the aim "To work towards an increase in the number of yellow-eyed penguins on a self-sustaining basis within their natural coastal ecosystem". This aim remains today, as hoiho have been reclassified to nationally endangered (2017).

# How do I do this?

Please contact your solicitor or legal advisor about leaving a bequest in your Will (or to make a Codicil, an addition to your existing Will).

The only information you require is the Trust's legal name and charity registration number:

## Yellow-eyed Penguin Trust Charity Registration Number CC22822

Making a legal Will is the only way to ensure your wishes will be met in relation to the distribution of your assets. A Will also helps to avoid confusion over your intentions and gives you peace of mind.
