### What we do


The Trust's conservation strategy is aligned closely with the Department of Conservation's recovery plan for yellow-eyed penguins/hoiho. We are minimizing mortality associated with introduced mammalian predators and recreating high quality breeding habitats, using thousands of plants grown in the Trust's nursery. We pursue these essential tasks in our own reserves and elsewhere. The work is complemented extensively by education and awareness activities.

The Yellow-eyed Penguin Trust, founded in 1987, is New Zealand's leading authority on yellow-eyed penguins and their conservation. We are New Zealand's first single-species conservation trust.

## **Yellow-eyed penguins / hoiho /** *Megadyptes antipodes*

Hoiho are unique to New Zealand, their natural range extends from Banks Peninsula to the subantarctic Auckland and Campbell Islands. The International Union for the Conservation of Nature and Natural Resources (IUCN) ranks the birds as *endangered* owing to their restricted range, extinction pressures in their marine and terrestrial environments, and their extreme fluctuations in numbers.

#### **About the Team**

The Trust Board has the capacity of up to 15 persons. It has two main sub-committees; the Conservation Management Committee which oversees all the field operations, and the External Relations Committee although this committee is currently in recess.

The staff team is managed by the General Manager as representative of the Trust Board. There are weekly staff meetings each Tuesday providing an opportunity to discuss work plans and catch-up on what is generally happening for each staff person and the Trust in general.

### Location

The Trust's work covers the geographic range of the yellow-eyed penguin which is from Banks Peninsula south along the eastern coast of the South Island, Stewart Island and the sub-Antarctic Auckland and Campbell Islands.

The Trust's office is based in John Wickliffe House in Central Dunedin, and the plant nursery is based at Company Bay on the Otago Peninsula.

This position will be based out of the Trust's Office, Level 1, John Wickliffe House, 265 Princes Street, Dunedin.
